Assembly and Installation

This section describes basic assembly for the 30" cocktail cart. Assembly includes:

- Connecting the fresh water lines
- Installing the sink drain
- Installing the transformer
- Installing the hardware

Parts List

Before you begin, open all of the packages and remove the packing materials. You should have the parts listed below. If you do not, contact Cal Spas customer service.

Connecting the fresh water lines

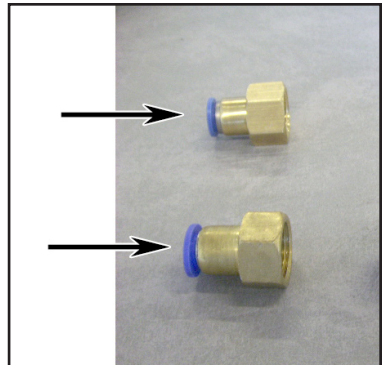
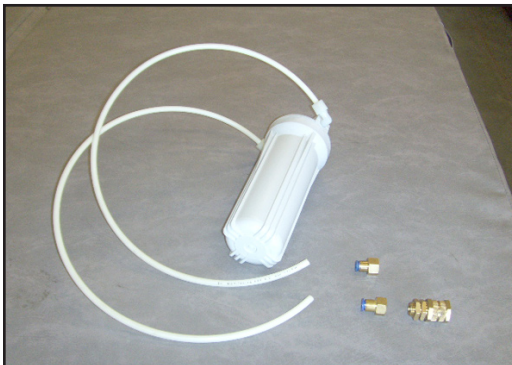
1. Remove the stainless steel panel on the back (six screws).



2. Remove the water filter and the metal filter holder from inside the cabinet. Remove the filter holder simply by lifting it up from the support pins.



3. If they are not already attached, push the water lines into the connectors.

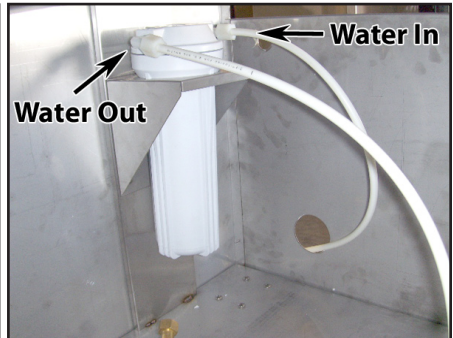
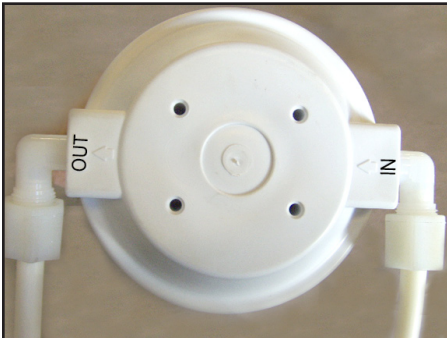
4. Screw off the top of the water filter and remove the filter.

Remove the plastic wrapper from the water filter cartridge.

Replace the water filter cartridge in the water filter and screw the top back on snugly.



5. Place the water filter and the filter holder back in the cart with the IN water line toward the back of the cart.

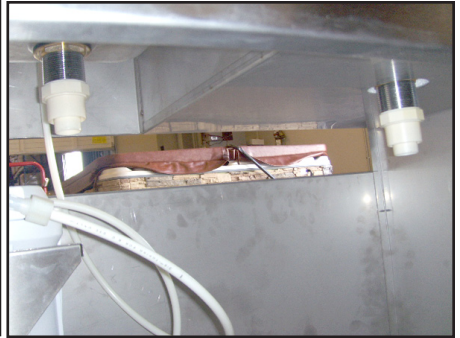
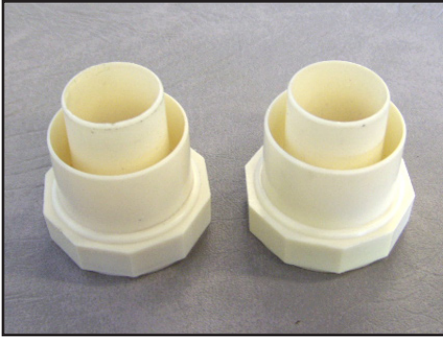


6. Connect the OUT water line to the faucet through the opening in the back of the cart.
7. Replace the stainless steel panel on the back.

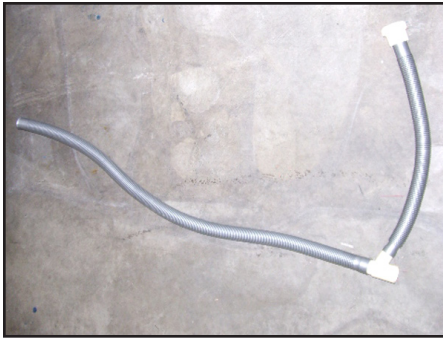


Installing the sink drain

1. Install the two plastic drain fittings by screwing them on the drains of each sink.

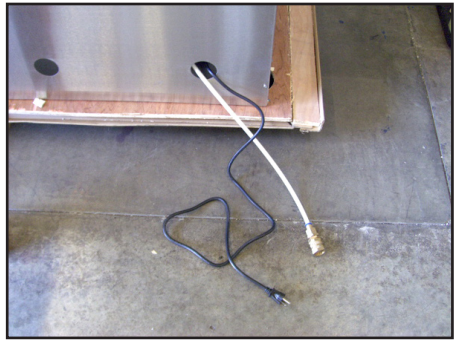
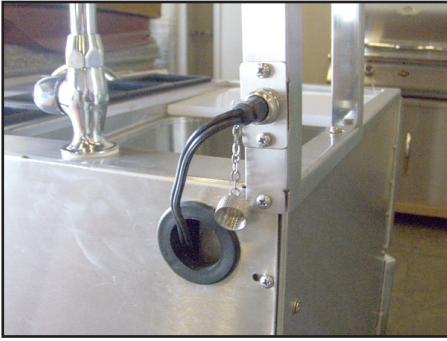


2. Attach the drain hoses to the T-connector as shown below.
3. Compress the hoses to the ends of the plastic drain fittings and place the drain hose through the opening in the back of the cart as shown below.



Installing the transformer

1. Unwind both power cords on the transformer.
2. Place the transformer beneath the water filter in the storage cabinet.
3. Extend the cable with the plug for the cart through the hole in the top right corner of the back of the cart.
4. Extend the power cable from the transformer through hole in the bottom right corner of the cart.

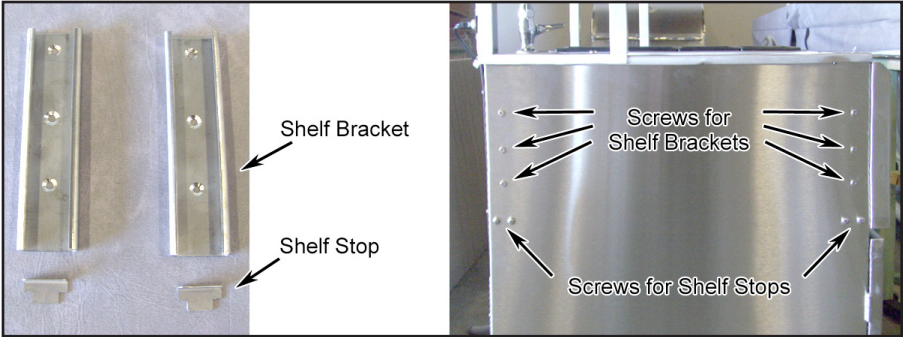


At this point, the back of the cart should look like this.

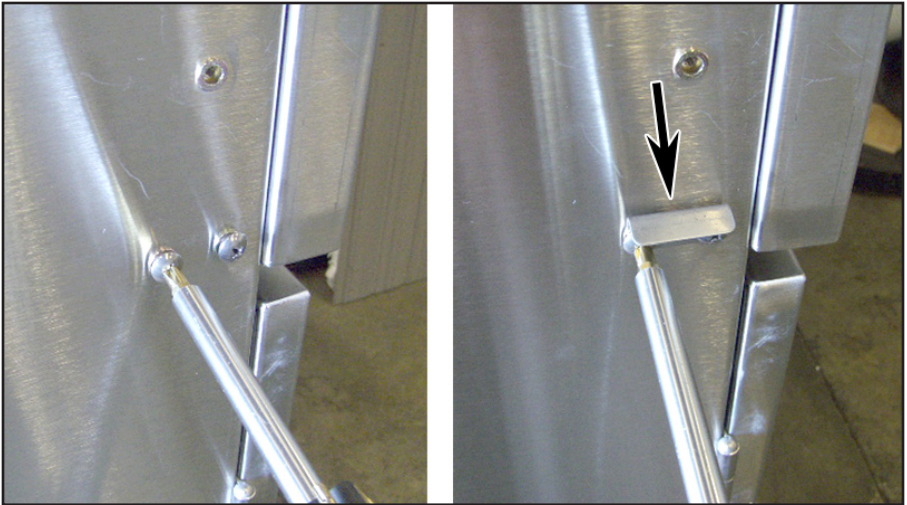


Installing the hardware

1. Each side shelf requires two brackets and two shelf stops. The mounting screws are already in place on each side.



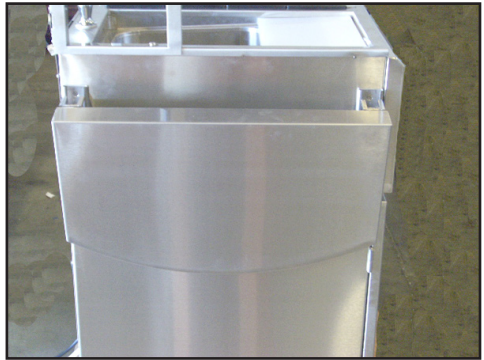
2. Loosen (but do not remove) the two screws for the shelf stop. Slide the shelf stop beneath the screw heads and tighten them.



3. Remove the three screws for the shelf bracket and mount the bracket as shown below.



4. Do the same for the second shelf bracket and shelf stop. Slide the shelf in place as shown.



5. Remove the packing materials from the bottle rack, the bottle cap catcher, and the bracket for the stainless steel bins. Hang them in their respective locations.

Attach the hooks to the front of the shelves.



Use, Care and Maintenance

To assure safe and proper maintenance, we recommend you follow these directions carefully.

Care of Stainless Steel

Do NOT use wire wool pads, scrappers, harsh abrasive, scoring materials, bleaches, or harsh cleaners. This will cause scratching, scoring, rusting and pitting.

We recommend that you clean stainless steel components with a cleaner that is approved for stainless steel and only clean when the oven is cool and in indirect light. Never use steel wool.

Use mild cleaners, such as soapy water or mild liquid sprays. Wipe with sponge, damp cloth or paper towel.

Repair

Unless specifically recommended in this manual, do not repair or replace any part of the cocktail cart except as specifically recommended in this manual. A qualified technician should perform all service. Any repairs made by a non-L.M.S. approved dealer technician will void your warranty.

Limited Warranty

Lloyds Material Supply (L.M.S.) offers the following limited warranty against defects in material and workmanship on the 30" cocktail cart:

- Lifetime limited warranty against deterioration and corrosion of the stainless steel cart
- One year limited warranty against defects in material and workmanship
- 90 day limited warranty for faucet, drain, and water supply system

Extent of Warranty

This 2008 Cal Flame Warranty is only valid on Cal Flame cocktail carts delivered in the United States or Canada and extends through the selling dealer to the original purchaser. This warranty becomes valid at time of purchase and ends

either by specified time-frame listed above or upon owner transfer or relocation.

Warranty Performance

In the event of a malfunction or defect covered under the terms of this warranty, a factory authorized service agent of L.M.S. will perform the necessary repairs. To obtain service, contact the selling dealer. In the event the consumer is unable to obtain satisfactory customer service from the selling dealer or service agent, written notification must be given to the L.M.S. Customer Relations Department within 30 days of the reported failure. There will be no charge for parts or labor on a covered item within the one year warranty period. However, the service agent may assess a reasonable travel or mileage charge per service call. If L.M.S. determines that repair of a covered item is not feasible, L.M.S. reserves the right to replace the defective merchandise with merchandise equal in value to the original purchase price. Warranty repair and / or replacement is the sole discretion of L.M.S. and this warranty does not cover costs therein, including but not limited to: freight, removal, re-installation, etc. This warrant is non-transferable and may not be extended beyond the above mentioned time frames under any circumstances, by any of L.M.S.'s representatives.

Warranty Limitations

This warranty is void if the cocktail cart has been subject to negligence, alteration, misuse, repairs, dings, dents, scratches, or incorrect and / or prohibited applications, as specified in the owner's manual. Incorrect electrical installation by unlicensed electricians, service by non-L.M.S. authorized representatives, acts of God and other cases beyond the control of L.M.S. are not covered by this warranty. Please refer to the owner's manual for examples of exclusions and common acts invalidating this warranty. This limited warranty applies only to cocktail carts and associated hardware used for personal, family, and outdoor household purposes. This warranty does not apply to labor charges. This limitation is retroactive and applies to all cocktail carts and hardware manufactured from 2000 and hereafter.

Disclaimers

L.M.S. shall not be liable for loss of use of the cocktail cart and related hardware or other incidental or consequential costs, expense or damages. Any implied warranty shall have duration equal of the applicable warranty stated above.

This limited warranty gives you specific legal rights. You may have other rights, which may vary from state to state.
